The Plant Nursery Evaluator (PNE) shall:

- Conduct inspection and evaluation of the plant nursery as soon as all the documents required are completed and submitted;
- 2. Prepare the appropriate evaluation report giving emphasis in the recommendation and identified species and varieties of fruits, plantation and root crops produced in the nursery for the issuance of certificate of accreditation;
- 3. Submit evaluation report to NSQCS Regional or Satellite office in their region copy furnish to Regional DA-Regulatory Division;
- 4. Assist the Plant Material Inspector in the evaluation and validation of mother trees planted in the established foundation/scion groves, budwood, clonal and seed gardens of the accredited plant nurseries for Plant Material Certification;
- 5. Conduct monitoring of accredited plant nurseries for proper nursery management.

The Plant Material Inspector (PMI) shall:

- 1. Conduct field and nursery inspection and validation prior to certification;
- 2. Submit preliminary and final inspection reports to the DA-RFOs and NSQCS Regional and Satellite Stations for proper documentation;
- 3. Validate status of trees and seedlings applied for certification;
- Supervise tagging of foundation/scion trees as well as budwood, clonal and planting materials in coordination with region;

- Submit report of accomplishments, e.g. status/condition of grooves and mother trees, nursery planting materials, field inspections and certification to the NSQCS Regional/Satellite and Central Office furnishing copies to the respective DA-RFOs'
- 6. Conduct periodic monitoring of certified mother trees and certified planting materials.

This memorandum order shall take effect immediately upon approval.
