- 7. Facilitate the endorsement of their managed records files to the Records Section in the event where the concerned document/s will be needed and used as references for legal matters and other concerns.
- 8. Facilitate faster and efficient information dissemination of official communication within their respective office/s.

In view thereof, the aforementioned employees are directed to faithfully perform their duties and responsibilities inherent to their designation in addition to their present workloads.

This Order shall take effect immediately and shall supersede all other orders inconsistent herewith.
